KDOT announces January bid awards

The Kansas Department of Transportation today announced approved bids for state highway construction and maintenance projects in Kansas. The letting was held Jan. 18, 2012 in Topeka.

District One - Northeast

Douglas – County Road 1374, ½ mile south of K-10, grading, bridge and surfacing, Comanche Construction, Inc. and Subsidiary, Shawnee Mission, \$2,753,110.43.
